**NO.PAS/Legis-B-26/2020**-The Barrett Hodgson University at Karachi ( Amendment) Bill, 2020 having been passed by the Provincial Assembly of Sindh on 11<sup>th</sup> January, 2021 and assented to by the Governor of Sindh on 26<sup>th</sup> January, 2021 is hereby published as an Act of the Legislature of Sindh.

**THE BARRETT HODGSON UNIVERSITY AT KARACHI (AMENDMENT) ACT, 2020  
SINDH ACT NO. I OF 2021**

**AN  
ACT**

**to amend the Barrett Hodgson University at Karachi Act, 2015.**

**WHEREAS** it is expedient to amend the Barrett Hodgson University at Karachi Act, 2015, in the manner hereinafter appearing; **Preamble.**

**It is hereby enacted as follows:-**

- 1. (1) This Act may be called the Barrett Hodgson University at Karachi (Amendment) Act, 2020.** **Short title and commencement.**  
**(2) It shall come into force at once.**
- 2. In the Barrett Hodgson University at Karachi Act, 2015, hereinafter referred to as the said Act, throughout the Act, for the words “Barrett Hodgson University” wherever appearing, the words “Salim Habib University” shall be substituted.** **Amendment of Sindh Act No.XL of 2015.**
- 3. In the said Act, in section 2, after clause (g), the following new clause shall be inserted:-** **Amendment of section 2 of Sindh Act No.XL of 2015.**  
**“(gg) “Commission” means the Sindh Higher Education Commission established under the Sindh Higher Education Commission Act, 2013(Sindh Act No.XI of 2013);”.**
- 4. In the said Act, in section 17, in sub-section (1) –** **Amendment of section 17 of Sindh Act No.XL of 2015.**
  - (i) in clause (e), after the word “Commission”, the words “of Pakistan” shall be added;**
  - (ii) after clause (e), the following new clause shall be inserted:-**  
**“(ee) the Chairperson, Sindh Higher Education Commission or whole time member of the Commission to be nominated by him;”;** and
  - (iii) in clause (f), for the word “Education”, the words “Universities and Boards” shall be substituted.**
